## **EQUIPMENT PURCHASES**

Hausdorf requested to finance the following equipment purchases through a lease purchase agreement: Mission Cellular Monitoring System-notifies public works when pump stations and lift stations are malfunctioning, \$3,734.80; Dehumidifier for the water treatment to help reduce humidity and increase the life of the equipment in the plant, \$3,162; 1 ton pickup truck, \$24,483; O'Brien model 7040-SC jetter, \$47,963.90; John Deere Z930M Commercial ZTrak Mower, \$8,434.58; mixer shaft for lime slurry, Janney motioned to approve the purchase of the equipment and Wolf seconded. Janney motioned to spend money from reserves for an 8 foot precast concrete vault for the water meters at the CLSW Fab Storage facility, Carlin seconded and the motion carried.

Phillips explained, if Ideal was not able to purchase the City property located at 2<sup>nd</sup> and Clark, their next move would be to find space out of town. If the City sells the property and purchases the property at 4<sup>th</sup> and Grant, the property at 4<sup>th</sup> and Grant would have to be developed. Currently there are no office space or bathroom facilities at this location. The City's current property at South Fourth Street could benefit UFC once the City was ready to sell. After Phillips presented the pros and cons of selling the City property, Wolf

## **CONSENT AGENDA**

Motion was made by Upchurch and seconded by Steinbeck to approve the items on the Consent Agenda: Approval of minutes from June 15, 2015 Regular Board Meeting and June Committee Meetings, June Collector's and Treasurer's reports and appropriations. Motion carried.

## **PROCLAMATIONS**

Two new businesses have opened in town: Pub 3one4 owned by Linda Duncan and Gary Golden and Ernst Storage owned and operated by Rick Ernst. Proclamations will be presented to the individuals at a later date. Proclamations will be mailed to each of the Ameri Corps individuals for their services while here in Canton for two months.

## RESIDENTIAL SEWER ISSUES

Phillips explained he met with Rodney Johns, Kaye Johns and Pat Cummings regarding sewer backups during the 3 to 4 inch rain falls that have occurred. Mr. Johns has a toilet in his basement that is at the same level as the sewer main and the valve he has in the basement no longer works. Phillips informed Mr. Johns the City will not pay to repair his valve. Kaye Johns and Cummings yards flood during the heavy rains when the sewer line fills and then exits the system through Ms Johns' sewer access. Hausdorf explained the sewer main takes a 90 degree turn at Sixth Street and when the main lift station gets full the sewer system backs up in this area. The main lift station has been in a state of alarm more often than not due to the heavy rains. No action was taken.

## MAIN STREET TREE PLANTING

In connection with Culver-Stockton College's Extreme Dome Makeover Day, Canton Main Street LLC has requested permission to plant 16 trees in the City right of way along Lewis Street. A map of the tree planting locations was presented to the Board. Steinbeck motioned to approve the tree planting as proposed contingent on proper marking of utilities is executed. Carlin seconded the motion and the motion carried.

#### **CASEY'S GRANT**

Crist requested permission to submit an application to Casey's General Store for a grant of \$500 to be used for the parks. A grant from Casey's last year was awarded to the City and used to purchase signs notifying individuals to clean up after their pets for the parks. Upchurch motioned to authorize Crist to submit a grant application on behalf of the City and Bracey seconded; the motion carried.

## MO DEPT OF CONSERVATION SOUTH PARK

The Missouri Department of Conservation has provided a new community assistance program agreement for the Canton Ferry Access area, often referred to as the river front south park area. The agreement provides for the Department of Conservation to replace

the existing asphalt road and parking area with a concrete road and parking area. The City is responsible for the removal of the existing asphalt. The agreement is for a period of 25 years. Upchurch motioned to authorize the Mayor to sign the agreement with the Department of Conservation and Janney seconded, motion carried.

## SALE OF JETTER

The City of Canton received one bid for the sale of the City's sewer jetter. The Minimum bid was \$7,500 for just the jetter and the bid received was for \$12,032.52 including the cutter heads. The cutter heads can be purchased for approximately \$3,000. The trade in value for the jetter is \$5,000. Carlin motioned to accept the bid received for the jetter in the amount of \$12,032.52 contingent upon the arrival of the newly purchased jetter for the City. Bracey seconded and the motion carried.

## SALE OF MORTON BUILDING

City property located at 210 North Second Street, often referred to as the Morton Building, was advertised for sale with a minimum reserve of \$70,000 for the property. Two bids were received; the first bid was for \$21,000 and the second bid was for \$70,000. The sale of the City property is contingent on the purchase of the property located at 508 North 4<sup>th</sup> Street. Steinbeck motioned to accept the bid for \$70,000 contingent on the purchase of the property located at 508 N. Fourth Street from Moller-Vanderboom Lumber Company which has to file financial statements with the State of Missouri to be in good standing prior to the sale of the property. Upchurch seconded the motion and the motion carried.

## STREET IMPROVEMENT LIST

Residents on Tenth Street between Clark and College expressed their concern of a 3 inch overlay on this street, residents are concerned the overlay would create flooding on their property. The increase in the height of the street would impede drainage during heavy rains causing the water to be trapped in their yards. Residents would prefer to see the road milled and then paved. Current funding and time restraints will not allow for these changes. It was agreed to eliminate this street from the current project list and add Jamison Street between 5<sup>th</sup> a 6<sup>th</sup> this would have all 4 continuous blocks of Jamison Street from 4<sup>th</sup> to 8<sup>th</sup> paved. Fifth Street from Jamison to Henderson was added as well as Third Street from Madison to Jefferson. Bland Street between 14<sup>th</sup> Street and 15<sup>th</sup> Street has been removed from the list while Lewis Street from 4<sup>th</sup> to Front and Clark Street from 5<sup>th</sup> to 7<sup>th</sup> will still remain on the list. Based on the proposed streets to be improved W.L. Miller submitted the low bid of \$189,126.90 for the street improvements. Bracey motioned to accept W.L. Miller's low bid of \$189,126.90 and Upchurch seconded the bid. Motion carried.

## **EQUIPMENT BIDS**

Two bids for the purchase of a dehumidifier for the water treatment plant were received. Ressler was the apparent low bidder with a bid at \$3,009.52; the other bid from Sidener was \$3,162.00.

## **EQUIPMENT BIDS cont.**

Broadway Ford, through the State of Missouri bid procurement process, advertised a bid of \$25,246.00 for a 1 ton 4x4 Ford. However, when Hausdorf contacted Broadway Ford the bid was actually only for a two wheel drive 1 ton Ford. The next lowest advertised bid was Joe Machens Ford at \$25,792 for a 1 ton 4x4.

Carlin motioned to accept the low bids from Ressler and Joe Machens Ford and Steinbeck seconded and the motion carried.

# FINANCE LEASE PURCHASE

Phillips explained the City of Canton advertised for bids for a lease purchase agreement for the following purchases and street improvements: Street improvements of \$189,126.90; Ford 1 Ton 4x4 25,792; Dehumidifier \$3,009.52; lime mixer shaft; John Deere Mower \$8,434.58; O'Brien jetter \$47,963.90; Mission Unit \$3,735; Upchurch motioned to purchase the items as presented through a lease purchase in the amount of and not to exceed \$321,000. Bracey seconded and the motion carried.

Canton State Bank was the low bidder with an interest rate of 1.89%. Peoples Bank and Bank of Monticello both offered a rate of 2%. Bracey motioned to accept the bid from Canton State Bank at a rate of 1.89% and Janney seconded. Motion carried.

## ANNEX HIGHWAY P MODOT RIGHT OF WAY

Phillips explained the City annexed area along Route P west of Highway 61, but the City limit sign cannot be moved until the City adopts the MoDOT right of way on the south part of Route P. Janney motioned to annex the right of way along Route P from MoDOT and Carlin seconded the motion. Motion carried.

# CLARK COUNTY WATER DISTRICT WATER PURCHASE

John Wood needs water in order for his cold storage facility to be up and running. The cold storage facility uses water to cool the warehouse and bring the temperature down to twenty degrees. The quickest and easiest way to assist Wood and provide water to the new facility is to buy water from Clark County Water District (CCWD). Hausdorf explained CLSW Fab & Storage can be connected to the new 6 inch water supply line and, where it is to connect to the 12 inch water line, install a temporary connection to CCWD's water supply line. Upchurch authorized the Mayor to sign an agreement with CCWD to supply water to the CLSW Fab and Storage facility. Bracey seconded the motion and the motion carried.

## BLUE VALLEY PUBLIC SAFETY AGREEMENT

Bracey motioned to renew a one year maintenance agreement for the outdoor sirens with Blue Valley Public Safety for the amount of \$3,984. Carlin seconded the motion and the motion carried.

## OTHER BUSINESS

Phillips requested approval of the Mayoral Appointment of Erin Allison to the Canton Public Library Board of Trustees. Steinbeck motioned and Janney seconded, motion carried.

Officer Clanton has been with the City of Canton for six months and Phillips requested approval of his six month probationary raise. Carlin motioned and Upchurch seconded to approve Clanton's six month probationary raise of an additional twenty five cents an hour. Motion carried.

Phillips asked the Board to authorize the use of City trucks to assist the City of Quincy with the hauling of trees downed during the recent storm. The City of Canton would be responsible for the gasoline and wear and tear on the trucks but the employees would be volunteering their time. Upchurch motioned to allow the City trucks be used to assist the City of Quincy, pending this activity will be covered by MIRMA, Bracey seconded the motion and the motion carried.

Janney stated Hausdorf and the City crew did and awesome job clearing the streets after the storm on July 14<sup>th</sup>. Kudos!!

## **BORING UNDER HIGHWAY 61**

Three bids were received for boring under Highway 61 for water and sewer lines to newly annexed area west of Highway 61. Wiemelt Plumbing was the highest bid at \$237,780. Sullivan Excavation bid \$100,800 and MB Construction bid \$119,918.60 for HDP casing. Discussion regarding MB Construction's alternate bid for steel casing pipe at \$94,520.00, versus Sullivan Excavation's alternate bid of \$110,500.00. Based on the bid specifications the contract is to be awarded based on the base bid, therefore Sullivan Excavation is the apparent low bidder. Steinbeck motioned to award the boring contract to Sullivan Excavation and Upchurch seconded. Motion carried.

## AMEREN MISSOURI

Hausdorf explained Ameren MO has offered 3 options for extending three phase electricity to the annexed area, west of Highway 61, for the City of Canton. Option 1, Ameren MO would install primary underground cable, the transformer and the meter for a cost of \$32,500. Option 2, Ameren MO would only provide the transformer and the meter for \$10,500 and the City would be responsible for providing and installing all secondary conductors from the pole to the meter location and provide the meter location itself. Option 3 Ameren MO would provide and install overhead materials at a cost of \$16,500. Upchurch motioned to proceed with option one with a not to exceed amount of \$32,500. Wolf seconded and the motion carried.

## **CATFISH TOURNAMENT**

Phillips requested approval for the Tourism Commission to sponsor prize money if a Missouri State catfish record is broken during the catfish tournament being held on August 8<sup>th</sup>. Wolf motioned to approve the prize money and Upchurch seconded and the motion carried.

## PHEASANTS FOREVER

Hausdorf inquired if the local chapter of Pheasants Forever could plant a pollinator plot at Second and Green Street. Pollinating animals include Hummingbirds, bees, wasps, butterflies, moths, and beetles. By feeding on flowering plants, they pollinate other plants so that they might bear fruit and seed. Such pollinators account for up to 85 percent of the pollination of flowering plants. In addition two-thirds of food crops require such pollination. The Pheasants Forever requests a five-year commitment. No action was taken

# **CULVER-STOCKTON COLLEGE PARKING**

Culver-Stockton College has requested temporary parking in the yellow zone area along Washington Street Homecoming weekend October 23 from noon to 11:00 p.m. and October 24<sup>th</sup> from 8:00 a.m. to 6:00 p.m. Upchurch motioned to allow for temporary parking along the yellow curbs Homecoming weekend and Carlin seconded. Motion carried.

## TRAC PHONE PROTEST

A lawsuit has been filed against Trac Phone for the payment of franchise taxes. The City of Canton will automatically be included in the lawsuit unless the City chooses to opt out. No action was taken.

## **ROOF PITCH CITY CODE 500.045**

Ken Rieffer of 801 College requested a change to the ordinance regulating the pitch for the roof of an accessory building. Rieffer is currently in the process of building a garage and the maximum pitch of 4:12 is flat compared to the pitch of his house. Rieffer explained his house was built in 1863 and has at least a 5:12 pitch. The current rule of no greater than 4:12 pitch will not allow for additional storage space and will not match the roof line of his house. Hausdorf explained the maximum 4:12 pitch was established to limit the height of the overhead door on an accessory building. After further discussion Upchurch motioned to have the City Attorney change section 500.040 paragraph C number (6) to, the minimum pitch of the roof shall be 4:12. Steinbeck seconded the motion and the motion carried.

## PROMOTION OF RYAN CLANTON TO SERGEANT

Chief Ryan Crandell has requested Ryan Clanton be promoted to Sergeant. Phillips stated Clanton has been very thorough and a good role model to the younger officers. The promotion does not include a pay raise. Janney motioned to promote Clanton to Sergeant and Bracey seconded. Motion carried.

# **OC's HOMECOMING REQUEST**

OC's has requested 5<sup>th</sup> Street be closed from Clark Street to the alley to the north between Clark and College. The request is for Culver-Stockton College's homecoming weekend on October 23rd. Carlin motioned to allow for the closure of 5<sup>th</sup> Street from Clark to the alley from 4pm on October 23<sup>rd</sup> until October 24<sup>th</sup> one hour prior to the start of the Homecoming Parade. Upchurch seconded and the motion carried.

## MISSOURI USE TAX

The Missouri Municipal League provided limited information regarding municipalities being able to continue to collect sales tax on vehicles purchased outside of their City limits. Phillips requested the City Attorney to investigate further and if voter approval is necessary, expect this item to be included on the ballot in April 2016.

# SNY LEVEE DISTRICT

Phillips notified the Board of the Sny Levee Districts ineligibility for the USACE PL 84-99 program for "unauthorized alterations" to the levee.

Pub 3one4 submitted an application for Sunday sales and has paid the licensing fee. Bracey motioned to approve Sunday sales pending State approval and Upchurch seconded the motion. Motion carried with 4 aye votes, 1 absent and Steinbeck abstaining.

# OTHER BUSINESS -MAYORAL APPOINTMENT

Matt Holt has agreed to serve on the Planning Commission for Ward Two and Mayor Phillips requested the Board's approval to appointment Holt to the Planning Commission. Upchurch motioned to approve Holt's appointment to the Planning Commission and Steinbeck seconded. Motion carried.

## **OTHER BUSINESS -TAX LEVY**

Phillips made the Board aware of a software issue that has caused the City to bill the same tax levy for the past three years. Calculations show the net difference is one and an eighth of a cent. The State Auditor's office was contacted and the City was advised to seek legal counsel. Attorney Smith will look further into the matter.

## PSBA CHANGE ORDER FOR LEVEE WORK

D&L Excavating is currently completing the levee work and the City requested a change order from PSBA for additional rip rap on the western side of the north levee to eliminate scouring and sluffing. The change order for 1,330 tons of rip rap at \$58 a ton and seven 8 hour days, \$200 per day for cleaning the ditch on the north side came to a total of \$88,862. The City will bid this additional work to the levee at a later date.

## **PUBLIC COMMENTS**

Smith inquired about the status of this year's road improvements. Phillips explained the contractor cannot find pea gravel in the area to complete the chip and seal.

Crist stated Donna Blickhan called City Hall requesting no parking on 7<sup>th</sup> Street at the end of Montgomery Street. When people park on both sides of 7<sup>th</sup> Street it creates an impasse. Phillips assigned the Public Works Committee and the Police Committee to come up with a solution.

## FINANCE COMMITTEE

Upchurch reported Finance met and worked on updating the City Code and the personnel manual. Upchurch presented the following changes: Currently the City Code only encourages City employees to live in the City and the personnel manual allows for employees to live 15 miles from Canton. It was agreed 15 miles was too far and that when an employee wishes to live outside City limits it would require Board approval. Uphcurch motioned to have the City Attorney draft an ordinance amending section 120.090 requiring a City employee to have Board approval to live outside City limits. Bracey seconded the motion and the motion carried.

Upchurch identified and explained the need to repeal section 120.100 of the internal hiring preference and motioned to have the City Attorney draft an ordinance to repeal section 120.100. Steinbeck seconded the motion and the motion carried.

The City Code reference to outside employment was also discussed by the Finance Committee. It was agreed to allow the employee supervisor/department head to approve outside employment and it was their responsibility to notify the Board of Aldermen of the employee's outside employment. Upchurch motioned to have the City Attorney amend the City Code to address the approval of outside employment. Steinbeck seconded the motion and the motion carried.

## **PUBLIC WORKS**

Hausdorf reported Public Works met and reviewed current projects. Regarding the project on the hill: the lift station is in and they are waiting on pumps; there is no electricity but the conduit is under the road; and dirt and clay is being hauled and added to the area near the lift station to provide a level place to pull in and park by the lift station. There is water in the 12 inch main, but there is a leak at a coupler that will be repaired tomorrow. The Central Park Project will be done this week. The electrical at 508 N. Fourth is not good and current work includes installing a new electric panel, conduit with outlets down each side of the building and new LED lighting.

# **POLICE COMMITTEE**

Janney reported the Police Committee will meet next week.

Phillips reminded the Board there is still the potential for litigation in connection with the police incident on

The type of materials to be used for constructing a chicken coop, vaccinations, building permits, and the potential for drawing other wildlife into the community were discussed. Upchurch motioned for the City Attorney to draft an ordinance regarding chickens with additional research and including the requirement for a permit. Bracey seconded and the motion carried.

## MUTUAL COOPERATION AGREEMENT with Culver-Stockton College

A mutual cooperation agreement between Culver-Stockton College and the City of Canton was presented for approval. The agreement was reviewed by the City Attorney and found to be satisfactory. Wolf motioned to authorize Mayor Phillips to sign the mutual cooperation agreement with Culver-Stockton College, Upchurch seconded the motion and the motion carried.

## DOG PARK - PARKS BOARD

Parks Board has requested permission to approach Charles Industries for the land south of the current Park at Brose and Wyaconda Avenue. The land would be used for a dog park. Tourism is in support of the dog park and Smith explained if the dog park were to be advertised in literature for the City of Canton tourism funds could be used to help sustain the dog park. Steinbeck motioned to allow the Parks Board to approach Charles Industries for the land south of the new park at Brose and Wyaconda Avenue. Upchurch seconded. The Board was made aware of the fact that the cost of a land survey could be incidental to the acquisition of the land. The motion carried.

## YELLOW CURB REQUEST – 413 Lewis

Robert Janney has requested a yellow curb in front of the East Overhead door of Janney Builder Supply to help keep it clear for access. City Attorney Smith stated no ordinance would be required to prohibit parking at this location. The City Code Section 355.010(A)(2)(a) already prohibits parking in front of a public or private driveway. Hausdorf will work with Robert Janney on posting a sign or painting the curb.

## LEVEE UPDATE

Phillips explained to the Board of Aldermen the results of the levee survey recently conducted by PSBA. Survey points were taken every 40 feet along an imaginary line on top of the levee. The survey points indicate the height of the levee has been restored to within an inch and a half of the 498 feet and 10 inches of the original design of the levee. The cotton wood trees have been removed from the toe of the levee and clay has been compacted into the holes where the trees were removed. The trees were approximately 60 to 70 years old and the trees themselves were holding water.

## **CHANGE ORDER #1 LEVEE RIP RAP**

Change order #1 for the installation of an additional 260 tons of rip rap at the riverside east abutment omitting the need to mow the slope, and 130 tons of rip-rap at the west side of the levee along the ditch to repair washouts from the field to the north. The cost of the change order is 260 tons at \$54.00 a ton or \$14,040.00 Steinbeck motioned to approve the change order and Wolf seconded. Motion carried.

#### **PAY REQUEST**

D&L Excavating, Inc. has submitted a pay request for \$42,736.75 which is the total of the balance of the original contract \$28,696.75 plus the \$14,040 for the change order. Steinbeck motioned to approve the pay request for D&L Excavating, Carlin seconded the motion and the motion carried.

Section 120.260 of the City Code covering maternity and paternity leave shall be replaced by the Family Medical Leave Act and its guidelines. Section 120.280 regarding volunteer firemen shall be amended to state public works employees shall be paid for only scheduled work hours when called to assist with a fire. This section of the code shall also be amended to state Police officers are not allowed to participate as volunteer firemen during scheduled hours or while on-call as an officer. The Police Department will be participating in the trunk-or-treat on October 31<sup>st</sup>.

## **PUBLIC WORKS**

Carlin reported Hausdorf and himself met with Patrick Hollensteiner about a water leak at 509 Madison. At this time Hollensteiner was asked to report to the Board of Aldermen about the leak. Hollensteiner reported that he lives at 509 Madison with Josh Davis and that his cousin Levi Locket was living there previously. Hollensteiner proceeded to share with the Board of Aldermen the series of events that led to a several hundred dollar water bill do to a water leak. Hausdorf and Crist retrieved and shared the history of the water account. There was much discussion about the notification process when a water leak is identified and the issuance of a credit in the event of a water leak. Steinbeck motioned to credit the water account \$250.00 and amend and refigure the bill and penalties. The motion died for lack of a second.

Hausdorf explained the amount of water that had passed through the meter before personal contact was made notifying the customer there was a leak which comes to a total of \$337.57. # POLICE VEHICLE PURCHASE

In light of this information, the Police Department would like to search for a new vehicle, borrow the funds from the General Fund and pay it back. PSBA submitted a pay request for Safe Routes to School Engineering for the amount of \$2,797.57 for engineering from June to October 15<sup>th</sup>, 2015. Bracey motioned to approve the pay request and Carlin seconded. Motion carried.

## ADVERTISE FOR BIDS FOR COPIER

City Hall will be advertising for bids for a new copier. No action was necessary.

#### OTHER BUSINESS

Phillips explained to members of the Board that Don Cibert has inquired if the fee for the Board of Adjustment application could be waived. Smith stated the fee is established by ordinance and cannot be waived.

## PUBLIC COMMENTS AND QUESTIONS

Janney inquired about the City sidewalk being replaced on Washington Street. Janney was concerned about the quality of the sidewalk because the forms were set to follow the lay of the land. ## WTP OPERATOR RETAINER CONTRACT

Dan Dover has submitted his resignation effective January 2, 2016 which leaves the City without a B licensed water treatment plant (WTP) operator which is not in compliance with DNR requirements. Bill Shaffer does have a B license, but does not wish to be the WTP operator. The City is seeking to contract with Dover until a B license operator can be found or created from within. Brian Laws is within 9 months of being a B license operator and interested in the position. Dover has provided a contract requesting a payment of \$400.00 biweekly, the equivalent of \$200.00 a week, and visit the WTP 4 times a month. The contract also lists various reports Dover would prepare and provide to DNR. Hausdorf stated he could prepare the reports and the payment could be on a per visit basis versus a biweekly payment. Upchurch motioned to authorize the Mayor to negotiate a contract with Dover with a not to exceed amount of \$150 per week. Steinbeck seconded the motion and the motion carried.

## COPIER BID

Phillips presented the copier bids and explained the preference was to remain with a black and white copier. Four bids were received: from Golden Ruler, RTD, Watts, and the Business Center. Janney motioned in favor of the Watts Copier and Upchurch seconded the motion. Carlin and Steinbeck abstained from voting, motion carried with 4 aye votes.

## VEHICLE SALES TAX AUTHORIZATION TO BALLOT

The residents of the City of Canton did not vote for a use tax when it was put to a vote in the past and without the use tax, any sales tax currently collected on vehicles will be lost due to a loophole. The estimated loss of sales tax from the sales tax on vehicles to the City of Canton would be \$7,564.00 annually. The collection of a vehicle sales tax will have to go to a vote of the people and pass prior to November 2016. Upchurch motioned to proceed with placing the vehicle sales tax on the April ballot. Janney seconded and the motion carried.

## **TUITION REIMBURSEMENT**

George Hausdorf recently completed 9 credit hours of college courses and has submitted the appropriate documentation for reimbursement. The reimbursement rate of \$298.00 per credit hour, based on Truman State Tuition rate, comes to a total reimbursement amount of \$2,682.00. Janney motioned to approve the tuition reimbursement for Hausdorf, Upchurch seconded and the motion carried.

## POLICE VEHICLE

Chief Crandell has received two bids to date for a new vehicle from Don Brown and Machens. Janney stated the 2007 Impala currently has no value and if it were to be repaired at a cost of \$1,000 there might be \$500 of value by the time the new vehicle arrives. Consensus was to repair the 2007 Impala. Upchurch motioned to authorize the purchase of a new vehicle with a base bid not to exceed \$28,000. Wolf seconded the motion and the motion carried.

## **USE OF FOUR WHEELERS ON CITY STREETS**

Phillips explained he has been asked about four wheelers on City streets several times and would like the Board to address this question directly. Discussion about four wheelers versus utility vehicles and side by side vehicles followed. No action was taken.

## CHICKEN ORDINANCE

There were no recommended changes to the proposed chicken ordinance.

# **CHICKEN PERMIT**

The proposed permit application for chickens was reviewed. The inclusion of no renewal if cited for a violation of the chicken ordinance and the inclusion of no grandfathering was requested.

## LEVEE PUMPS

The vertical turbine pump at the south pump station has multiple problems and the pump is no longer manufactured and needs to be replaced. The cost of a replacement pump will be approximately \$30,000.00. The pump will be paid for from the 2014 general obligation bond funds of which there is \$269,616.00 available. Steinbeck motioned to proceed with the purchase of a new vertical turbine pump for the south pump station. Wolf seconded the motion and the motion carried.

## PROPOSED NO PARKING ON MONTGOMERY

There were no concerns or changes regarding the proposed ordinance for no parking on Montgomery Street.

No action necessary.

## Bill No. 15-22 Ordinance NO. 763-C

Wolf moved to have the first reading, by title only, of Bill No. 15-22, proposed Ordinance NO. 763-C, an Ordinance Authorizing a Petition for Voluntary Annexation of Contiguous Territory to the City of Canton, Missouri, Consisting of a Portion of Missouri State Route P Upchurch seconded the motion. Motion carried. Following its reading by Smith, Upchurch moved to have the 2nd reading, by title only, and Bracey seconded. Copies of the proposed bill have previously been made available to the public. Motion carried and the ordinance was read.

Bracey moved to adopt Bill No. 15 - 22, and assign it Ordinance No. 763-C and Upchurch seconded.

Finance met: discussed the increase in sales tax revenue; the condition of the Recycling Center and a request for Kell to put together a proposal for the building; discussion of the current budget and begin preparation of the new budget next month; a new roof for City Hall with solar panels; and Maine Street has 18 student helpers next semester.
