#### School Memorandum of Understanding/ School Resource Officer

The MOU will spell out the responsibilities of each party and how they will deal with certain situations. Discussion was then had regarding a school resource officer. Canton RV has budgeted \$15,000 toward the hiring of a future resource officer.
