



REGULAR BOARD MEETING
JANUARY 19, 2021

Mayor Phillips called the meeting to order at 7:01 pm. In attendance were Phillips, aldermen Bracey, Janney, Mathieson and Upchurch, Steinbeck and Hausdorf. Also in attendance; City Attorney Smith, City Clerk Seangmany, Public Works Director Kell, Chief Crandell and Brian Laws.

CONSENT AGENDA

Motion was made by Upchurch and seconded by Mathieson to approve the items on the Consent Agenda: Approval of minutes from December 22, 2020 Regular Board Meeting. Motion included approval of minutes of Committee Meetings, December Collector's and Treasurer's report and appropriations. Motion carried.

CANTON SCHOOL CHOICE PROCLAMATION

Motion was made by Bracey declaring January 24-30, 2021 as School Choice Week. Janney seconded, motion carried.

MUTUAL COOPERATION AGREEMENT WITH CSC

Motion was made by Upchurch to accept the Mutual Cooperation Agreement with Culver-Stockton College. Steinbeck seconded, motion carried.

WATER METER PURCHASE REVIEW

Mayor Phillips informed the board of the error in the bid award letter leading to a complete meter replacement throughout the city, rather than just replacing the meter reading devices and certain meters. Motion was made by Hausdorf to approve the additional expenditures of the water meters in the amount of \$108,000. Funds will be borrowed from the General fund and paid back with interest from the Water Fund until it is paid off. Mayor Phillips will prepare a payment schedule for a period of 24 months. Possible ways to pay off the debt early would be to use the proceeds from the sale of the current street shed location, or use money from the general fund that was reimbursed from the CARES Act funds. There is also the possibility of using the "freed reserve" balance from the original General Obligation Bond finance agreement. The amount of money available for the GO Bond is anticipated to be approximately \$50,000. Further discussion will occur at the February Regular Board Meeting. Upchurch seconded, motion carried.

INFORMATION TECHNOLOGY BID REVIEW

Motion was made by Hausdorf to reject all bids at this time. Mathieson seconded and motion carried.

Motion was made by Steinbeck to seek bids for a server and a replacement for the city clerk's computer which is using Windows 7. Funding for the computers is already in the budget. Upchurch seconded, motion carried.

ELECTRONIC METER READING DEVICE DAMAGE POLICY

The Board has decided to make the public aware of the cost for damaged water meter reading devices via Facebook and water billing messages. Cost to replace these devices is \$150.00 per unit. At this time Public Works Director Cindy Kell will monitor damaged devices and if it continues to be a problem it will be brought back to the Board of Alderman.

REGULAR BOARD MEETING
MARCH 15, 2021

Mayor Phillips called the meeting to order at 7:00 pm. CONSENT AGENDA

Motion was made by Upchurch and seconded by Mathieson to approve the items on the Consent Agenda: Approval of minutes from February 16, 2021, Regular Board Meeting and Committee Meetings, February Collector's and Treasurer's report and appropriations. Motion carried.

PREFERRED FAMILY

Jessica Baker MS, LPC, CRADC presented the Board of Aldermen with information about what services Preferred Family Healthcare offers to the community. Mayor Phillips and the board agreed to allowing Preferred Family sit at the City Hall to provide information to the public, as well as making brochures available to the community. Mayor Phillips also requested more information on cost regarding certain programs they offer.

PAY REQUEST #2-WHISTON CONSTRUCTION-NEW CITY HALL

Motion was made by Janney and seconded by Steinbeck to authorize the pay request of \$62,100. Motion carried.

WADE STABLES FORENSIC AUDIT

Motion was made by Hausdorf to approve the estimated cost not to exceed \$8,000 for a forensic audit of certain systems within the city and seconded by Steinbeck. The audit will take place in the late spring or early summer. Motion carried.

SALE OF CURRENT PUBLIC WORKS BUILDING

A closed session will be placed on April's Regular Board Agenda for the proposed sale of the Public Works and the City Hall Buildings.

APPRAISAL OF CURRENT CITY HALL

Motion was made by Janney and seconded by Hausdorf to approve for the City Hall building without the parking lot included to be put out for bid for appraisal. Motion carried.

METER REPLACEMENT PROGRAM STATUS REPORT

The Public Works Director is still investigating how many meters need replacement and how many meters we have installed in vacant locations. The board would also like a policy in place so that residents are notified of any water leak visible through the new Beacon monitoring system. Mayor Phillips will develop a policy to review data and notify residents of possible leaks.

NEW 5-YEAR WATER PLAN PROGRAM

The board discussed that Public Works Director Kell needs to develop a system improvement plan and present to the Board of Aldermen for approval, then have it reviewed by an engineer prior to sending it to the Missouri Department of Natural Resources. They suggested if extensions to the system are known now, they should be included on the 5-year plan program.

REVIEW COUNCIL/COURTROOM DIAS PLAN

Motion was made by Bracey and seconded by Mathieson to approve the purchase of the dias from MO Vocational Enterprises in the amount of \$1,929.00. Motion carried.

REPAIR ESTIMATE 2013 POLICE TAURUS

The Police Taurus vehicle needs numerous repairs. The estimate is \$3,500 to fix. The board agreed that the cost is most likely the full value of the vehicle currently and to leave the car at the repair shop until a decision is made on what to do with the car.

PAY REQUEST #3-BLEIGH CONSTRUCTION NEW PUBLIC WORKS FACILITY

Motion was made by Upchurch and seconded by Bracey to authorize the pay request of \$94,840.02. Motion carried.

CLOCK TOWER PLAN /IDEAS

Mayor Phillips does not feel the City can afford to place clocks on all four sides. Phillips suggest doing the North and South side. At this time the estimates the city has received are \$8,000 to 10,000. Attorney Smith will review the authorizing ordinance for the tourism tax to determine if that particular revenue could be used to assist in funding a clock. The Tourism Committee could then be approached to see if they have any interest in helping fund this project. Alderman Upchurch also suggested checking in the Nichols Foundation. This will be revisited at the April Regular Board Meeting.

JUNETEENTH FIREWORKS REQUEST

Motion was made by Upchurch and seconded by Janney to approve the request for fireworks to be shot off for the Juneteenth celebration. Motion carried.

OTHER BUSINESS

Aldermen Bracey has received 4 complaints on the parking on 4th street with a boat, van and horse trailer obstructing the view and limited parking spaces. Chief Crandell reminded the board that it is a State Highway and it is 2-hour parking. Attorney Smith is going to look into this matter further to check the City Ordinance to see if anything can be done.
