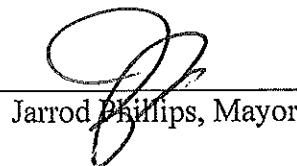
Alderman Hausdorf wanted to thank the City of Canton for allowing Monroe City to borrow the generator while the City's power was out.
